COVID-19: PASSENGER RESTRICTIONS

- E) FOREIGN CITIZENS WHO MEET THE CONDITIONS FOR ARRIVAL IN BOSNIA AND HERZEGOVINA PRESCRIBED BY THE LAW ON ALIENS, CAN ENTER BOSNIA AND HERZEGOVINA UPON PRESENTATION OF A NEGATIVE PCR TEST FOR SARS-COV-2 VIRUS, WHICH IS NOT OLDER THAN 48 HOURS FROM ARRIVAL AT THE BORDER CROSSING OF BOSNIA AND HERZEGOVINA.
 - WITHOUT PRESENTING A NEGATIVE TEST FOR THE SARS-COV-2 VIRUS, THE FOLLOWING MAY ENTER BOSNIA AND HERZEGOVINA:
 - CITIZENS OF MONTENEGRO, THE REPUBLIC OF CROATIA AND THE REPUBLIC OF SERBIA, WHEN THEY ENTER BOSNIA AND HERZEGOVINA DIRECTLY FROM THE COUNTRY OF WHICH THEY ARE CITIZENS, AS WELL AS THEIR MINOR CHILDREN AND SPOUSES WHO ARE CITIZENS OF OTHER COUNTRIES
 - CREW AND CABIN CREW OF THE AIRCRAFT WHOSE FINAL DESTINATION IS BOSNIA AND HERZEGOVINA,
 - -DIPLOMATIC CONSULAR STAFF ACCREDITED (RESIDENT) IN BOSNIA AND HERZEGOVINA MUST POSSESS AND PRESENT DIPLOMATIC CARD OF THE MINISTRY OF FOREIGN AFFAIRS OF BOSNIA AND HERZEGOVINA (TYPE
 - D, MO, K, S, PO, PK, PP) AND A VALID PASSPORT.
 - CIVIL PROTECTION SERVICES AND TEAMS WHEN THEIR ENTRY INTO BOSNIA AND HERZEGOVINA IS URGENT AND IMMEDIATE
 - -MEMBERS OF MILITARY FORCES OF NATO STATES AND OTHER STATES WHICH PARTICIPATE IN THE PARTNERSHIP FOR PEACE, NATO HQ MEMBERS AND EUFOR IN BOSNIA AND HERZEGOVINA
 - -HEADS OF STATE AND MEMBERS OF THEIR DELEGATIONS WHOSE ARRIVAL AND DEPARTURE HAVE BEEN ANNOUNCED TO THE BIH BORDER POLICE THROUGH DIPLOMATIC CHANNELS OR THROUGH
 - PROTOCOLS OF THE COMPETENT BIH AUTHORITY.
 - FOREIGN CITIZENS TRANSITING THROUGH THE TERRITORY OF BOSNIA AND HERZEGOVINA FOR THE PURPOSE OF RETURNING TO THE COUNTRY OF RESIDENCE, WITHOUT RETENTION ON THE TERRITORY OF BOSNIA AND HERZEGOVINA.

-FOREIGN CITIZENS ARE OBLIGED TO FOLLOW AND RESPECT ALL INSTRUCTIONS AND ORDERS OF THE COMPETENT AUTHORITIES OF BOSNIA AND HERZEGOVINA, EPIDEMIOLOGICAL AND HEALTH SERVICES.
